Mr. Garland Nessmith has submitted an application asking to rezone his property (34.75 acres) off of Old Leefield road in Brooklet, GA. The property is currently zoned A-1 (agricultural district) and he is requesting that it be rezoned to R-2 (single-family residential district). The purpose of the rezone is to allow for single-family residential areas with minimum lot sizes of 15,000 square feet for developing a subdivision.
