WORK SESSION & CALLED MEETING MINUTES OCTOBER 08, 2020 6:30 PM

1. Call to Order by Mayor Joe Grooms, III

PRESENT: Greg Schlierf, Brad Anderson, Lori Phillips, Nicky Gwinnett, Jim Stanoff, Bill Griffith presided.

2. Work Session Items:

- **2.1. Financial Update** Councilman Anderson reported that as of October 3rd, our ending balance for the General Fund is \$60,000.00; he would like to recommend that we go ahead and borrow a tax anticipation note up to \$100,000.00 from the Bank of Newington.
- **2.2. Cares Act Update** It has not been decided rather there will be a Phase 2 or not.
- **2.3. FEMAC Security Systems Proposal for Cameras at Public Works** we will need two cameras installed, one for the gas tank and one for the city shop. This can wait until January.
- **2.4. Halloween** Scheduled from 6 PM to 8 PM, October 31, 2020
- **2.5. GovDeals Fair Market Value of Equipment** we need to prepare an idolized list and set a reserve on all items. Once we approve the information, we can then advertise for the sale.

- **2.6. Personnel Policy Employee Drug Screen** This item will be placed on hold and we will reach out to GMA for more information.
- **2.7. Employee Motor Vehicle Records** we require MVRs when the employee is hired; we will investigate through the DMV services on how the City can get updated MVRs on employees driving City vehicles.
- **2.8. Sanitation Truck Software** Councilman Schlierf stated that the software is called Trash Flow, we can download a free demo and check all reviews online.
- **2.9. Safety Update** Councilman Stanoff reported that the Safety Grant was approved and has been received.
- **2.10. Public Work Job Descriptions** Councilman Schlierf will try to have the job descriptions prepared for the City Council meeting.
- **2.11. Well House Repair Work** Mayor Pro-Tem Gwinnett has received a quote for \$24, 087.00 from Altamaha Building Systems, Inc. for repairs to the well houses and the city shop.
